This Supplement (the “**Supplement**”), to the Prospectus (the “**Prospectus**”) dated 12 November 2013 which comprises a base prospectus as supplemented by a Supplementary Prospectus dated 20 February 2014, a Supplementary Prospectus dated 24 February 2014 and a Supplementary Prospectus dated 16 April 2014, constitutes a supplementary prospectus for the purposes of Section 87G of the Financial Services and Markets Act 2000 (the “**FSMA**”) and is prepared in connection with the Euro Medium Term Covered Note Programme (the “**Programme**”) established by OP-Asuntoluottopankki Oyj (the English translation of which is OP Mortgage Bank) (the “**Issuer**”). Terms defined in the Prospectus have the same meaning when used in this Supplement.

This Supplement is supplemental to, and should be read in conjunction with, the Prospectus and any other supplements to the Prospectus issued by the Issuer.

The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

#### **Purpose of this Supplement**

The purpose of this Supplement is to:

- (a) incorporate by reference the Issuer’s unaudited non-consolidated interim financial statements titled ‘OP Mortgage Bank Interim Report for January –March 2014’ for the three months ended 31 March 2014 (the “**Interim Report**”); and
- (b) following publication of the Interim Report, update the statement of no significant change in respect of the Issuer.

A copy of the published Interim Report has been filed with the Financial Conduct Authority and, by virtue of this Supplement, the Interim Report (excluding the section entitled “Outlook” on page 2 thereof) is incorporated in, and forms part of, the Prospectus. Copies of all documents incorporated by reference in the Prospectus are available for inspection from the registered office of the Issuer and from the specified offices of the Paying Agents for the time being in London and Luxembourg. In addition, copies of the Prospectus, this Supplement and any other supplement to the Prospectus and each Final Terms relating to Notes which are either listed on the London Stock Exchange or offered to the public in the United Kingdom will be available on

#### **Incorporation of Information by Reference into the Prospectus**
